- Collective experience of pandemic has increased need for flexible funding including for staff, new staff, applying as needed. Funders have seen nationwide that funding staff is important.
- We're doing more compelling asks in applications, more urgently than in the past.
- Funder Priorities:
 - o Statewide funders, a lot have gone back to project, being "done with the pandemic".
 - o A lot of funders moved to gen. operating, Covid funding
 - o Challenging for arts, environment.
- Organization obstacles:
 - o A lot of organizations people are tired and short staffed. Data for report.
 - Hard to find staff for new programs. How much people are willing to get paid.
 - Remote affects how quickly people can respond.
 - o Can't do special projects because trying to serve clients.
 - o Also less money raised through events.
 - Suggestions moving forward:
 - Need to still educate Boards of Directors on on-going needs.
 - Communicate that to funders, and focus on equity and diversity. Look at statement and putting into practice.
 - Increasing salary, getting back to basics to fund programs adequately.
 - End of year funds we're interested in specific community.

LOIs poll 68% said less than 25% of apps require LOI 28% 25-50 More than 50%

- Some funders like Marie Lamfrom encourage communication before the application.
- Some LOIs are a way to weed out applicants vs. others that are an introduction.
- Some funders have higher likelihood of application award if you did LOI
- LOI Writing Tips
 - Funders can feel overwhelmed make LOI as easy to read/understand as possible.
 - o All of the project planning needs to be done **before** writing LOI.
 - o Need to use "constructive ambiguity" in language.
 - o Sometimes a lot of ideas generated after LOI.
 - o Make sure to specify how much funding you want for what project and why.
 - Oconnect the dots for why you're applying if it's a new funder vs. if it's a returning funder/program
- Funders can help by:
 - making application available in preview, make all questions really clear, allow attachments.
 - o Have list of specific areas to cover.
 - o Provide example of funded applications.
 - Share reasons for why we weren't funded
