WHY CERTIFY?

A professional certification or credential represents an objective measure of the level of experience and expertise in the profession as defined by the profession as a whole.

For fields such as the grants profession where there is no recognized academic degree, certification is the only authoritative, independent measure available by which to determine a person's experience, skills, and knowledge as defined by our peers.

OVERVIEW

The GPC Exam is designed as a test for a "generalist," who is defined as a person experienced and competent in the fundamentals of grantsmanship. Generalists may (and often do) possess proficiency at the mastery or distinguished level.

The GPC credential demonstrates mastery and is considered appropriate for those with a minimum of 3-5 years of grant experience and a demonstrated record of grant success.

To qualify for admission as a Grant Professional Certified (GPC)®, candidates

- Meet the minimum eligibility requirements
- Complete the application process
- Pass a two-part examination developed through rigorous national standards for professional credentialing

COMPETENCIES & SKILLS

The Grant Professional Certified (GPC) examination measures a candidate's competency and skill in the grants profession. The Competencies and Skills and the weight each should receive on the test are determined through rigorous processes that involve dozens of professionals nationwide, assisted by credentialing experts. THE EXAM

The GPC Exam includes two pass/fail components which must each be successfully completed: a 90-minute writing exercise and a 150-item multiple-choice section. The two components may be taken concurrently or at separate times. Candidates may take the exam electronically by reserving a seat at nearly 500 exam hosting facilities nationwide. EDUCATION

20 Points

- High school diploma or equivalent from US or foreign equivalent
- Associate degree or equivalent from US or foreign equivalent in any major, from an accredited college or university
- Successfully completed a technical training course of study
- Honorably completed military training (other than Basic Recruit Training)

Include a copy of degree(s) or transcript(s) indicating a degree was conferred (if applicable)

40 Points

 Minimum of a bachelor's degree or foreign equivalent in any major from an accredited college or university

PROFESSIONAL EXPERIENCE

50 Points

- Resume showing current/past employment, education, professional honors awarded, and other information appropriate to the field and your experience – must demonstrate a minimum of five (5) years of experience in the grants field within the past seven (7) years
- Completed "Documentation of Grants Experience," including a list of successful proposals within the last seven (7) years (minimum of five (5) grants; this need not be all inclusive)
- Three signed and dated letters from credible sources verifying your experience in the field of grants (letterhead or other verification required)

70 Points

- Resume showing current/past employment, education, professional honors awarded, and other information appropriate to the field and your experience – must demonstrate a minimum of three (3) years of experience in the grants field within the past five (5) years
- Completed "Documentation of Grants Experience," including a list of successful proposals within the last seven (7) years (minimum of five (5) grants; this need not be all inclusive)
- Three signed and dated letters from credible sources verifying your experience in the field of grants (letterhead or other verification required)

PROFESSIONAL PRACTICE / CONTINUING EDUCATION

50 Points

 List of up to 50 clock hours of grant-related professional practice activities or continuing education within the past two (2) years

40 Points

List of up to 40 clock hours of grant-related professional practice activities or continuing education within the past two (2) years

COMMUNITY INVOLVEMENT

50 Points

 List of up to 50 hours of community-based volunteer services within the past three (3) years

20 Points

List of up to 20 hours of community-based volunteer services within the past three (3) years

CANDIDATES MUST ACHIEVE 120 POINTS OUT OF 170 POINTS POSSIBLE

ELIGIBILITY & APPLICATION

To be eligible to take the GPC Exam, candidates must meet a minimum number of points across four professional areas: Education, Professional Experience, Professional Practice/Continuing Education, and Community Involvement.

Depending on educational background, candidates must have at least three to five years of experience in the grants profession and at least five successful grants in the past seven years. To learn more, take our Eligibility Quiz on the GPCI website.



CERTIFICATION MAINTENANCE

Because grant development, grant funding, and grant management are dynamic and rapidly changing fields, individuals are awarded GPC certification for a period of three years. To remain certified, every three years candidates must satisfy the minimum certification maintenance requirements, including completion of the CMP Application and payment of the certificate maintenance fee, or re-sit for the GPC examination.
